

FOREWORD

The importance of statistics in informing planning and monitoring of government programmes cannot be over emphasised. We need to know where we are, determine where we want to reach and also know whether we have reached there. The monitoring of socio-economic progress is not possible without measuring how we progress and establishing whether human, financial and other resources are being used efficiently.

However, these statistics have in many occasions been national in outlook and less district specific. The development of a district-based Statistical Abstract shall go a long way to solve this gap and provide district tailored statistics and will reflect the peculiar nature of the district by looking at specific statistics which would not be possible to provide at a higher level.

Data and statistics are required for designing, planning, implementing, monitoring and evaluating development programmes. For instance, statistics on school enrolment, completion rates and dropout rates etc. are vital in the monitoring of Universal Primary Education (UPE) and Universal Secondary Education (USE) programmes. Statistics are also needed for establishing grant aid to community schools, staff levels and other investments in the education programmes. The collection and use of statistics and performance indicators is critical for both the successful management and operation of the sectors, including Lower Local Governments.

For data to inform planning and service delivery it should be effectively disseminated to the various users and stakeholders. The initiative to compile this District Statistical Abstract is therefore an effort to support the Planning function of the Local Governments and other users interested in the Higher Local Government (HLG) statistics.

This District Statistical Abstract will go a long way in guiding District Policy makers, Planners, Researchers and other stakeholders to identify the indicators that are relevant for planning, monitoring and evaluation of Government programmes in their jurisdiction.

The Statistical Abstract will also act as an aggregation of statistics from all sectors and also information originating from NGOs and other organisations. This Statistical Abstract, therefore, is an annual snapshot documentation of the Kanungu District situation, providing a continuous update of the district status.

It is my sincere hope that the document will provide all interested users with adequate information and I also feel that where more information is required, appropriate departments should be contacted for details.

Lastly, I wish to thank the District Planning Unit staff especially Mr. Saturday Jackson who was coordinating the compilation of the Statistics and Information contained in this Abstract.

EXECUTIVE SUMMARY

The Statistical Abstract is an annual publication compiled by Kanungu DLG Planning Unit, which provides the statistical summary on various socio-economic indicators for the District. Some figures in this edition may vary from those in the earlier editions due to the updates. Note that some of the previous data presented in this edition are provisional and could be revised in subsequent publication of FY2022/2023.

This publication is 12 chapters which are come by departments and general information about the District. A set of Statistical Appendix Tables that are serialized, using a combination of numbers and alphabets, such as Table 1.1A, Table 2.3 B etc., are also provided for the readers' information. However, some information in this report is presented basing on the 18 LLGs as of July-2019.

CHAPTER ONE: INTRODUCTION

Background

1.1 Profile of the Local Government

1.1.1 Location and Size of the Local Government

Kanungu is one of the Districts in the South-Western region of Uganda. Kanungu District is located in south western Uganda between 29° 50'E and 0°45'S of the Equator, bordering the Districts of Rukungiri in the north and east, Kabale in southeast, Kisoro & Rubanda in the south and the Democratic Republic of Congo in the west (see map below). Its administrative headquarters are in Kanungu town, about 450 km from Kampala the Capital City of Uganda and the district has a total area of 1228.28 sq. km of which land area is 1179.25 sq.km

1.1.2 Historical Profile (Year created, significant changes that have occurred, major landmarks).

In 1962 at Independence, Kanungu District existed as one of the Counties of the former Kigezi (then called Kinkiizi County). In 1974, when Rukungiri District was created it became part of Rukungiri District. In July 2001, it achieved district Status comprising of 13 sub-counties and 4 town councils; Kanungu, Butogota, Kambuga and Kihihi Town Councils with 53 Parishes and 16 wards, and 514 villages. To date, the district is comprised of 18 sub-counties and 9 town councils.

1.1.3 Geographical Profile (Climate, Vegetation, Topology, Mineral resources, soils, water bodies).

Kanungu District is located in South-western Uganda between 29° 50'E and 0°45'S of the Equator, bordering the Districts of Rukungiri in the North and east, Kabale in southeast, Kisoro in the south and the Democratic Republic of Congo in the west. Its administrative headquarters are in Kanungu Town, about 450 km from Kampala the Capital City of Kanungu District was curved out of Rukungiri District and started its operations on 1st July 2001.The District is composed of 4 Town councils, 14 Sub counties, 16 wards, 57 parishes and 520 Villages The District has 136 Gov't primary schools, 19 Secondary schools, One Hospital, 2 HCIV's, 10 HC III's and 14HC II's.

1.2.3 Climate

The District has a tropical type of climate receiving moderate and fairly well distributed annual rainfall of about 1200m. The district receives a bimodal type of rainfall between the months of March - May and September – December every year. The rest of the months are dry with temperatures ranging from 15^oc to 20^oc on average.

1.2.4 Vegetation

Kanungu district has a total area of 1,228.28 sq. km, comprising 60 percent small-scale farmland, 15 per cent high tropical forest, 11 per cent woodland, 9 per cent grassland, 2 per cent bush land, one per cent open water and 2 per cent miscellaneous mosaics. The vegetation ranges from the high tropical forests of Bwindi impenetrable national park to the grasslands of Queen national Heritage.

Topography

Kanungu district lies in the fringes of the western rift valley with the Northern part forms part of the Rift valley with undulating plains with the middle part (sub-counties of Rugyeyo, Kirima and parts of Kanyantorogo) comprising of flat toped hills with gentle sloping sides and broad valleys. These hills gradually increase in height to the highlands of Rutenga with Burimbi peak of Mafuga being the highest at 82,222ft. (2,503m) above sea level with some parts of Kihihi Sub-county lying in the fringes of the western Eastern African rift valley.

Mineral Resources

Prospects of oil and gas products have been identified in Kihihi, Kayonza and Nyanga sub counties while Commercial iron ore deposits are found in Kyeshero Sub-county. Wolfram and gold have been prospected in Kambuga, Kanungu & Kihihi TCs and Mpungu Sub-county. Excavation of sand and clay is taking place mainly for construction in the Kihihi, Nyakinoni and Kambuga SCs.

1.1.4 Population and Demographics (Projected total population, sex ratio, rural & urban population, average household size, LG population as share of Uganda's population, languages spoken, literacy rates, etc)

To formulate present and future development programmes, the district needs to know the size, quality, distribution and growth of its population. Population censuses are the main sources of demographic data in general and information on population size, distribution and growth rate in particular. Other sources may include various surveys, Birth and Death Registration and Administrative Records.

Between 2002 and 2014, the population growth rate of Kanungu District was 1.7% i.e. 2002 (204,732) and 2020 (288,545) persons. If the population is left to grow by the same rate of 1.7% and slow decline of TFR from 4.7 (2014) to 3.7 (2040), the population of Kanungu District is estimated to be 508,850 persons in 2040

1.1.5 Economic Profile (Sources of livelihood, Main economic activities, poverty rates, industries, tourism potentials, other economic potentials of the LG, road network/transport network, ICT connectivity)

Poverty has many different dimensions, ranging from material well-being (basic needs of like nutrition, good health, shelter, education etc) to lack of human rights, citizenship or social networks. Economic factors such as low income, lack of assets, access to markets or public services can lead into poverty. Over 80% of households in the region are engaged in subsistence Agriculture as the main livelihood activity besides a few youths involved in tourism as guides. Tea and coffee are crops grown mainly for commercial purposes. Local and cross border trade with DRC and previously Rwanda is also a key activity in Kanungu. According to USAID estimates, the Kanungu has a total GDP of \$ 62.7M and GDP per capita for Kanungu stands at 210 US dollars. The size of the labour force is estimated to be 156,513. The labour Force Participation Rate (LFPR) indicates the proportion of working age population that is active in the labour market either employed or actively looking for employment. Those who were in subsistence agriculture only, not working and not actively looking for work, such as retired people.

Tourism


Kanungu district hosts two tourist destinations of international important sites; Bwindi Impenetrable world heritage in the west and Queen Elizabeth, Biosphere reserve in the North. These are areas of great diversity and provide a habitat of the endemic mountain gorilla and the highly vulnerable climbing lions respectively and ranks among the top six districts in the country. Other tourist attractions include birds and reptiles particularly in the Queen Elizabeth National Park and include Buffaloes, Elephants, Uganda Kobs, Toppi and many species of reptiles. The hospitality industry is also growing characterised by existence of Hotels and Resorts and employs 0.2% of the population.

1.2 Administrative Structure

The District follows a Local Governments System at different levels. Council consists of 50 councillors representing different Lower local governments (Sub-counties and Town Councils) and special interest groups. District is composed of 9 Town councils, 18 Sub counties, 102 parishes /wards and 530 Villages. The civil service is headed by the Chief Administrative Officer, supported by Department and sector heads. The role of the Local Governments is to implement and monitor government programmes at the respective levels.

1.3 Financing Framework

The LG financing framework entirely lies on the funds from the centre (95.5%), Donors other development partners (2.2%), and local revenue (2.3%). Direct Central Government grants and technical assistance and direct support from Donor Agencies for specific activities.



CHAPTER TWO: ADMINISTRATION DEPARTMENT

2.1 Introduction

The Mandate of the Department is to supervise, monitor and coordinate both Local and central Government programmes and policies, employees and all lower local councils. The strategic direction of the department as highlighted in the LGDP is to have a well dedicated motivated technical staff that is able to offer services to the people of Kanungu as prioritized in DDP III.

The production sector is comprised of five sectors namely: Agriculture, Veterinary Services, Fisheries, Entomology as well as Trade and Industry. The department also ensures that appropriate institutional linkages are maintained with all relevant sector agencies; comprising mostly crop, livestock, fisheries, forestry and industrial research, marketing organisations, NGOs and CBOs engaged in agricultural activities



















Figure: 8.3 Kanungu DLG surface area

Population Density

Population density refers to the number of people per square kilometre. Kanungu district has an area of 1228.1km². Therefore, the population density was 167 persons per km² of land in 2002 year. The population density increased from 167 persons per km² in the year 2002 to 198 persons per km² in the year 2014, 209 persons per km² in 2018 and 239 in 2019 and 235 persons per km² in 2021.

Urbanisation rates and levels

Urbanisation is defined as the increase in the proportion of the population living in the urban area. However, the definition of urban areas has been changing over time. The 2002 and 2014 censuses defined urban areas as only the gazetted ones while the earlier censuses included ungazetted urban centres with more than 1000 people as part of the urban population. While 234,154 (79.8%) live in rural areas, 59,381 (20.2%) live in urban areas. Most of the areas classified as urban areas in the district are peri-urban.

Refugee population

Kanungu District is hosts Matanda Refugee Transit Centre, located at Matanda village in Kihihi Sub County. It is an exit and entry point for refugees mainly from DRC and Rwanda. On a daily basis, Matanda Refugee Transit centre used to host 600 refugees due to tribal clashes, forced Rebel recruitments, abductions and death threats in DRC. However very many refugees have settled within the surrounding communities of the border of DRC and many organizations have come in to provide Humanitarian assistance and other services to the refugees coordinated by the Office of the Prime Minister. Details of the number of refugees hosted by District cat Matanda transit centre can be traced through the daily registration records.
